### PLEASE READ CAREFULLY, BEFORE YOU SIGN THE AGREEMENT

This signed agreement shall be binding between:

The Rider agrees to this release of claims, waiver of liability and assumption of risk. In the event any section of the release is found to be unenforceable, the remaining terms shall be enforceable.

Central Coast Mountain Bike Tours Pty Ltd owns and makes available for loan, the hire of a number of mountain bikes (herein referred to as "Bike") and biking equipment such as helmets, gloves and other gear (herein referred to as "Equipment"). The Bike and Equipment at all times remains the exclusive property of Central Coast Mountain Bike Tours Pty Ltd.

➡ **I am duly aware that mountain bike riding is a potentially dangerous activity.**

I am aware that mountain biking is a recreational activity which may involve, in addition to usual and inherent risks, personal injury, obvious risk, danger to myself, the possibility of injury and harm and physical exertion for which I may not be prepared, remoteness to normal medical service, weather extremes subject to sudden and unexpected change and evacuation difficulties if I am disabled.
